

Welcome to the 2019 MHI Excellence in Manufactured Housing Awards Competition Rules Page. Below you will find updated criteria for the 2019 Awards. Please carefully read this information about each award. Each award winner receives a personalized trophy and recognition in industry communications.

Awards in 2019 include:

Land-Lease Community of the Year- (East & West) *

Communities will be judged on quality rather than quantity so please focus your comments on quality issues (occupancy rates, resident satisfaction scores, low resident turnover) and share percentages rather than quantity (number of sites, number of new homes installed, etc).

Retail Sales Center of the Year- (East & West) *

Retail Sales centers will be judged on quality rather than quantity so please focus your comments on quality issues (customer satisfaction scores, demo home setup & décor, etc.) and share percentages rather than quantity (number of homes sold, number of employees, etc.).

Modular Housing Design Award

A home entered in this category must meet the following criteria:

- The modular housing project must have occurred after January 1, 2017.
- It must be must be built to the state or local building code.

Manufactured Home Design- (Multi-section & Single section)

A home entered in this category must meet the following criteria:

- The manufactured home project must have occurred after January 1, 2017.
- It must be must be built to the state or local building code.

National Energy Efficiency Leader of the Year

For the National Energy Efficiency Leader of the Year award, the entry should showcase your company's efforts to develop energy efficient solutions for manufactured housing.

Lender of the Year – (National and Regional)

Lender entries will be judged on quality rather than quantity so please focus your comments on quality issues (satisfaction scores, new lending programs, revised loan criteria, etc.) and share percentages rather than quantity (number of loans originated, dollar volume of loans originated or serviced, etc.).



Manufactured Home Lender/Broker of the Year

Broker entries will be judged on quality rather than quantity so please focus your comments on quality issues rather than quantity (number of properties sold, value of listings, etc.).

Manufactured Home Community Operator of the Year

Community operators will be judged on quality rather than quantity so please focus your comments on quality issues (occupancy rates, resident satisfaction scores, low resident turnover) and share percentages rather than quantity (number of sites, number of new homes installed, new communities acquired, etc).

Manufacturer of the Year - (Three Plants or More & Two plants or Less)

Manufacturers will be judged on notable achievements in producing manufactured housing during the past year. Please focus comments on quality issues rather than quantity.

Supplier of the Year

Suppliers will be judged on quality rather than quantity so please focus your comments on quality issues or innovation rather than quantity (number of locations or product lines, etc).

Interior Design Award


A home entered in this category must meet the following criteria:

- The interior design project must have occurred after January 1, 2017.
- It must be must be built to the HUD Code, or state or local building code.

Lender of the Year - Floor Plan

Lender entries will be judged on quality rather than quantity so please focus your comments on quality issues (improved inventory tracking process, satisfaction scores, etc.) and share percentages rather than quantity (number of retailers, value of loans, etc.).

What Happens to Your Entry:

Entries are screened at MHI headquarters to verify eligibility. All entries are judged by a panel of independent experts in the fields of architecture, development, home construction, multifamily housing, real estate appraisal, finance, public relations and community planning. The entries are evaluated using judging criteria based upon the submission information provided in this document. The highest-scoring entry in each category receives an award. The decision of the judges is final and scores for individual entries will not be disclosed.

Entry Deadlines, Fees and Rules:

If you apply by February 15, you will receive early bird pricing of \$75 for each entry. After February 15 until March 1, 2019, each entry is \$125. Entry materials must be entered into the online system by March 1, 2019. No refunds will be granted for entries withdrawn from the competition, late or incomplete entries, or entries determined not to meet the eligibility criteria. There will be no extensions to the deadline and no exceptions will be made.

Award Notification:

Award winners will be notified by no later than March 29, 2019.
